## About Doug

## Recent Notable Matters

***Toshiba America Electronic Components, Inc.*** — secured voluntary dismissal with prejudice and without any payment after four-year litigation over patents related to self-encrypting solid state and hard disc drives

***Toshiba America Business Solutions, Inc.*** — invalidated five patents related to facial recognition algorithms, digital marketing, and the capture and manipulation of digital images. Successfully argued and obtained affirmance of the judge's order from the Federal Circuit Court of Appeals.

**Big Fish Games** — over the course of three hard-fought cases, invalidated 11 patents asserted by three different entities. Included two appeals to the Federal Circuit.

**HTC Corporation** — Obtained a complete victory for consumer electronics company HTC in a trademark infringement case in the Eastern District of Virginia on summary judgment days before trial was set to begin. Successfully argued and obtained affirmance of the judge's order from the Fourth Circuit Court of Appeals. Subsequently obtained a ruling entitling HTC to recover \$1.5 million in fees based on the exceptional nature of the case.
