Lenzing Fibers Inc.

- development of its form Engineering, Procurement and Construction (EPC) Agreement to construct a state-of-the-art lyocell fiber plant with a production capacity of 90,000 tons per year at its site in Mobile, Alabama, with an expected investment volume of \$293 million (€ 275 million)

Major alcohol and spirits company

- prospective carbon dioxide purchase and sale Agreement (including related environmental attributes) with a major industrial gas supplier related to a renewable natural gas facility adjacent to the company's whiskey distillery*
