## Government Investigations

### Government outsourcing contractor

### Pharmaceutical company

- defended company against a grand jury investigation for alleged submission of improper claims for CMS reimbursement of off-label pharmaceutical sales. No charges were ever filed

### Air Force contractor

- defended company in a multi-year grand jury investigation into alleged collusive bidding on an Air Force professional services contract. DOJ

prosecutors closed the investigation without any charges being filed against the company or any individuals

- represented company indicted on price fixing conspiracy charges related to US military personnel household items. Bracewell negotiated a settlement of criminal charges and in parallel civil False Claims Act case. We also negotiated an administrative settlement agreement with the Army to avoid debarment related to criminal plea
